UNFINISHED BUSINESS	<ol style="list-style-type: none"> 1. Intubation Study Phase II - B. Clemency: 6 residents went through the study. 5 of the 6 passed on the 1st attempt on all positions. 2. ePCR Subcommittee: This new committee has just been developed, and still needs a Chair. R. Bartel from Rural Metro has volunteered to serve on the committee. Need input from agencies, NAC, PHAC. A Chair will be appointed in January for this committee. 3. Wilson VFC – Still no confirmation from Dr. Mullaney regarding a past equivalent to the Base Station Course. The committee feels that if a doctor has taken a course equivalent to the Base Station Course and can prove with either a certificate or similar. Ideally a certificate that confirms completion, and also an outline, agenda, or slides – to show the content of the course. 4. Therapeutic Hypothermia – Trial cooler with Rural Metro: First pt. expired, and the 2nd was brought in to BGH on 11/13, is still in ICU. Dr. Myers will continue to follow this patient’s case. LVAC has a 2nd cooler that will roll out shortly. The SEMAC is very interested to follow how these trial cases turn out. The WREMAC has solicited Program Agencies to assist finding agencies interested in participating in the Therapeutic Hypothermia study. Several have already showed / requested an interest. Discussion continued. Please contact Dr. Myers ASAP if your agency is interested in participating. 	
NEW BUSINESS	<ol style="list-style-type: none"> 1. NYS EMS Policy Statement 09-08 Reporting Incidents, injuries & crashes: The committee discussed / reviewed this policy statement. No data is available yet. 2. EO 29 – Approved training module has come out for EMS personnel. The only approved training module has been released and is only available on-line. Vaccinations are only to be done through either a county or state designated POD. 3. Tourniquets back into algorithm for hemorrhage control. The SEMAC will discuss this at their next meeting (December). BLS Protocols, curriculum may potentially be changed. 4. Winchester VFC – Application to upgrade from a BLSFR to an ALSFR-Intermediate. <p>ISSUES FROM THE FLOOR</p>	<ol style="list-style-type: none"> 1. S. Wander: Waveform Capnography discussion regarding agencies and the problems with purchasing the correct stand alone waveform Capnography units that they have purchased, but do not have the capability to print and / or store data. Agencies are overwhelmed and confused, and are being misled. The State Attorney General should be informed of companies misinforming and selling incorrect equipment. Scott will re-circulate the information to the agencies. Additionally, this issue will be taken to the SEMAC as well. 2. E. Mager brought up the S.A.L.T. airway device and asked if the Equipment Committee would consider researching this piece of equipment. Currently, WREMAC protocols ok FDA approved airway device with medical director approval. Also discussed the problem with individuals being taken off-line by their medical director, but notifying their local WREMAC or DOH, therefore the necessary information is not being circulated. Please make sure this is done so that it gets into the central system. 3. Discussed that some systems list providers on line, who have been credentialed. Suggestion that the QI Committee may slowly be able to tackle the issue of credentialing. 4. B. Clemency – Vigilant Guard report. Will bring a proposal forward to next meeting for review to trial cardio cerebral resuscitation with Orchard Park EMS. 5. C. Crawford discussed / requested the need for some WREMAC representation at the regional council meetings. Drs. Cooley and Myers will address this with further.
